

LAFCO MEETING MINUTES WEDNESDAY, OCTOBER 5, 2016

CALL TO ORDER

The meeting was called to order at 1:00 p.m.

2. PUBLIC COMMENTS

Doug Muirhead, a resident of Morgan Hill, stated that ground water recharge areas are unavailable in South County due to the proliferation of private wells. He urged LAFCO and the County to discuss policy in the future which would allow extension of water service or creation of micro water distributors to eliminate private wells, and allow creation of additional recharge areas.

The Chairperson, there being no objection, ordered that the agenda be taken out-of-order to allow speakers from the public to address the Commission before the Closed Session.

11. LAFCO OFFICE SPACE: AUTHORIZATION TO LEASE PRIVATE OFFICE SPACE

Commissioner LeZotte sought clarification on the recommended action and Ms. Palacherla advised that the lease agreement will be executed in coordination with the Ad Hoc Space Committee.

The Commission authorized the Executive Officer to execute a lease agreement for office space at 675 North First Street for a five-year lease term not to exceed a total cost of \$213,000 and authorized an expenditure of up to \$64,000 to address Life Safety improvement issues and permit / plan check fees, after coordinating with the Ad Hoc Office Space Committee and subject to review and approval by LAFCO Counsel. The executed lease agreement will be placed on the next LAFCO agenda for informational purposes.

Ms. Noel presented the staff report. She indicated that the Commission was provided with copies of a letter from Mr. Muirhead, and she acknowledged Santa Clara County Planning Manager Rob Eastwood in the audience.

In response to an inquiry by **Commissioner Hall**, Ms. Palacherla stated that she reported at the SDA meeting that LAFCO is looking for office space but did not indicate that there will be an increase in special district contributions as such information will only be known during the development of the budget for the next fiscal year. **Commissioner Hall** stated that special districts with small budgets should be made aware of cost increases in advance so they can prepare.

Ms. Noel reported that, as an additional item to the report, the property of Steve Burch has been annexed to the Town of Los Altos Hills in September 2016. **Commissioner Milius** expressed appreciation to staff for facilitating the completion of the project.

13. ANNUAL REPORT

Ms. Palacherla reported that Fiscal Year 2016 was an exceptional year for LAFCO. She informed that the Annual Report highlight the vital role LAFCO plays in promoting sustainable growth in the county. She indicated that the Commission had to make difficult, politically challenging decisions, and take took unprecedented actions to uphold LAFCO's goals. Ms. Palacherla recognized the Commission's leadership and commitment.

Ms. Palacherla directed attention to the graphs illustrating how some cities have been able to accommodate large population increase without expanding their boundaries. She also informed that San Jose's General Plan does not anticipate expansion of its boundary to accommodate growth over the next 20 years.

Chairperson Wasserman complimented commissioners and staff for their efforts.

The Commission accepted the 2015-2016 Annual Report (July 1, 2015 to June 30, 2016).

14. CALAFCO TESTIMONY AT LITTLE HOOVER COMMISSION (LHC) HEARING ON SPECIAL DISTRICTS

Ms. Palacherla presented the staff report.

Commissioner LeZotte inquired about the date of the next LHC hearing as the topic on climate change policy was of interest to the Santa Clara County Water District (SCVWD). Ms. Palacherla stated that she informed the SDA about the LHC hearing.

Commissioner Karla informed that he wrote an article in the San Jose Mercury News about the protection of the Coyote Valley. He noted that many people do not recognize land conservation's important role in addressing climate change.

In response to an inquiry by **Commission Wilson**, Ms. Palacherla noted that the Little Hoover Commission may come up with recommendations in the future but no information is available yet.

A brief discussion ensued about the contributions of the special districts in containing the Loma fire. **Commissioner Hall** informed that the Santa Clara Valley Open Space Authority (OSA) sacrificed some of its trails in order to create firebreaks. **Chairperson Wasserman** expressed appreciation to OSA and he reported that replacement vegetation in the firebreaks is planned to prevent erosion. He reported that he held community meetings in the South County, received updates and toured the headquarters of the interagency firefighting effort in Gilroy. **Commissioner LeZotte** informed that the SCVWD has opened its two reservoirs to fire helicopters, and that the District will acquire tanker trucks to provide drinking water to firefighters in future fire emergencies. **Chairperson Wasserman** described how the interagency Loma firefighting operation was organized quickly and efficiently, and expressed appreciation to the public safety sector for all their efforts.
