RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF SANTA CLARA COUNTY ADOPTING THE 2010 COUNTYWIDE FIRE SERVICE REVIEW REPORT, ADOPTING SERVICE REVIEW DETERMINATIONS, AND ADOPTING SPHERE OF INFLUENCE UPDATES AND DETERMINATIONS FOR LOS ALTOS HILLS COUNTY FIRE DISTRICT, SANTA CLARA COUNTY CENTRAL FIRE PROTECTION DISTRICT, SARATOGA FIRE PROTECTION DISTRICT, AND SOUTH SANTA CLARA COUNTY FIRE PROTECTION DISTRICT

RESOLVED by the Local Agency Formation Commission of Santa Clara County, State of California, that

WHEREAS, Government Code Section 56430 requires the Commission to conduct service reviews in order to prepare and update spheres of influence in accordance with Government Code Section 56425; and

WHEREAS, the Commission previously authorized the Countywide Fire Service Review and Sphere of Influence Updates to be prepared; and

WHEREAS, the Executive Officer set October 20, 2010 and December 15, 2010 as public hearing dates for the 2010 Countywide Fire Service Review and Sphere of Influence Updates; and

WHEREAS, the Commission considered the report of the Executive Officer; and the attachments thereto, the comments received in writing and comments presented at the October 20, 2010 and December 15, 2010 public hearings;

WHEREAS, the Commission, as Lead Agency has complied with the California Environmental Quality Act (CEQA), as described below;

NOW THEREFORE, the Local Agency Formation Commission of Santa Clara County does hereby resolve, determine, and order as follows:

SECTION 1:

The 2010 Countywide Fire Service Review and the updates to the Sphere of Influence (SOI) of the four fire districts are categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15306 Class 6 and Section 15061(b)(3) General Rule of the CEQA Guidelines;

SECTION 2:

The 2010 Countywide Fire Service Review Report is hereby adopted.

SECTION 3:

The Service Review determinations for the agencies included in the 2010 Countywide Fire Service Review Report, incorporated herein by reference, are hereby adopted.

SECTION 4:

The Sphere of Influence (SOI) determinations as included in the 2010 Countywide Fire Service Review Report and updates to the SOI boundary for the four fire districts are hereby adopted as follows:

- a. The SOI boundary for Santa Clara County Central Fire Protection District is retracted as recommended and depicted in the 2010 Countywide Fire Service Review Report.
- b. The SOI boundary for South Santa Clara County Fire Protection District is reaffirmed.
- c. A zero SOI boundary is established for Saratoga Fire Protection District.
- d. The SOI boundary for Los Altos Hills County Fire District is retracted as recommended and depicted in the 2010 Countywide Fire Service Review Report.


